FEES: Fees are based on a daily or pass plan and are due upon departure of pet's scheduled visit. A prepaid daycare pass can be purchased for 5 days, 10 days or 20 days. A pass is valid for 24 months from the date of purchase. Customer will be charged a \$25 handling fee for each returned check. First time customers, dog will not be released until payment is made in full.

DAYS and HOURS: We are open to the public Monday thru Friday from 7 a.m. – 7 p.m., Saturday 8 a.m. – 4 p.m., and Sundays and Holidays from 11 a.m. – 3 p.m. If customer does not pick up their dog(s) by 7:00 p.m. then Chicago Canine Club will board my dog(s) at the present overnight stay rate plus a penalty, provided there is space available. Please arrive before 11am for daycare, and please check-in for boarding before 3pm to participate in groups for that day.

SPAYING AND NEUTERING: All dogs older than 6 months of age must be spayed or neutered to be allowed in play groups.

ANIMAL FACILITIES / DOG PARKS: We discourage your use of other facilities/dog parks while attending CCC. If another Grooming Facility/Animal Facility or Dog Park is used, a 7-10 day buffer period is required between using any animal facility/dog park and using the Chicago Canine Club. If a Dog Park or Other Facility is used within the 7-10 day period, dog participation at Chicago Canine Club may be declined.

RESERVATIONS: Required. 24 hr notice must be given to attend daycare at CCC. Cancellations with no notice will be charged full fees. For Holidays, Spring Break and extended stays, we are accepting a one night <u>non-refundable</u> deposit to hold your spot. Dogs who have not been here for 6 months or longer are required to come in for a half day of charged daycare, as a refresher before next daycare or boarding stay.

GROOMING: An on-site bath is recommended on the day of departure for an additional charge. If you would like your dog to have a bath, full groom or haircut during a boarding stay, that can be coordinated with our Chicago Canine Club Staff, prior to boarding.

# AGREEMENT TO PARTICIPATE AND LIABILITY WAIVER

I understand certain "activities" that my dog may participate in, including daycare, boarding, one-on-one play, movement within and outside the facility, and transportation to and from Chicago Canine Club involve risk and possible injury, including but not limited to:

- Exposure to parasites, viruses, and other medical conditions passed from dog-to-dog or person-to-dog;
- Sprains, strains, bites, broken bones;
- Motor vehicle accident during transportation; and
- Fatigue, dehydration, nicks, cuts, or death.

I further understand that not each and every potential risk can be listed above but, nonetheless agree that the benefits associated with dog socialization and play outweigh the possible risks, therefore, I hereby voluntarily release, forever discharge, and agree to hold harmless and indemnify Chicago Canine Club and its agents, successors, heirs, from any and all liability, claims, demands, actions, or rights of action, which are related to, arise out of, or are in any way connected with my Dog's participation in activities at Chicago Canine Club, including those allegedly attributable to the negligent acts or omissions of Chicago Canine Club or their staff.

Further, I understand that I may be exposed to certain risks when bringing my Dog to participate in activities at Chicago Canine Club or when picking up my Dog from participating in activities at Chicago Canine Club. Such risks may include property damage and/or physical injury inside or outside the facility, such as from falling, slipping, illness, and/or dog bites. Therefore, I hereby voluntarily release, forever discharge, and agree to hold harmless and indemnify Chicago Canine Club, its agents, successors, heirs from any and all liability, claims, demands, actions, or rights of action, which are related to, arise out of, or are in any way connected with my Dog's participation in activities at Chicago Canine Club, including those allegedly attributable to the negligent acts or omissions of Chicago Canine Club or their staff

<b>ALLERGIES, SPECIAL DIETS, MEDICATIONS</b> I agree that I will disclose to Chicago Canine Club any allergies my Dog may have. I further agree to disclose to Chicago Canine Club any special dietary needs or medications my Dog may require if necessary during activities at Chicago Canine Club.
 <b>PHOTOGRAPHS AND STATEMENTS</b> I authorize use of my dog's visual image(s) and statements in newsletters, posters, and other materials.
 VICIOUS TENDENCIES I affirm that I am not aware of any vicious tendencies by my Dog. I have shared any information that I'm aware of my dog biting a person or another animal.
 AGREEMENT TO PAY Chicago Canine Club accepts check, cash, or credit cards. I agree to pay the service rates in effect for my dog's participation in activities at Chicago Canine Club. I further agree to pay for any additional services requested such as grooming or training services. All services must be paid in full before Dog will be released to Client.
 SUPERVISION
Daycare rooms are supervised from 7:00 a.m. to 7:00 p.m. However, this does not mean constant supervision from within the daycare room. Also, at our discretion, boarding may not be supervised overnight.
 BOARDING
All boarding cancellations must be made 24 hours prior to check in. If a cancellation is not made 24 hours prior to check in it will be considered a "no show." Also considered a "no show" will be all instances where a dog is not checked in at all for a boarding reservation. All "no show" incidents will be

	VETERINARY RECORDS
	My Dog's complete veterinary records must be furnished to Chicago Canine Club.  These records must include proof of vaccinations and/or treatment for: parvovirus, distemper, Bordetella, heartworm, fleas, and ticks.  Records may be sent via facsimile to: 630-655-8907.
	I further attest that my dog is free of parasites and other illnesses that can be transmitted from dog-to-dog. Due to the high risk of dog-to-dog transmission of such parasites and/or viruses, I agree that I will immediately notify Chicago Canine Club if I learn or suspect my Dog has parasites or viruses; and agree to not bring my Dog to Chicago Canine Club for any activities if my dog has been to another boarding/grooming/daycare/training facility or dog park, for 7 days or until I receive clearance from Chicago Canine Club, in conjunction with my Dog's veterinarian.
	<b>EVALUATION OF DOG PRIOR TO PARTICIPATION</b> Every Dog must be evaluated by Chicago Canine Club prior to participating in any activity. Evaluations are done during late morning hours Tuesday, Wednesday or Thursday's. Such evaluation may assess the Dog's temperament and interactions with other dogs and Chicago Canine Club staff.
	RIGHT TO DECLINE I understand that Chicago Canine Club reserves the exclusive right to decline participation or to
	terminate participation in activities at Chicago Canine Club to any Dog at any time for any reason.
	ATTORNEY FEES, APPLICABLE LAW & VENUE Should Chicago Canine Club, or anyone acting on their behalf, be required for any reason to incur attorney fees and costs to enforce or defend this agreement, I agree to indemnify and reimburse Chicago Canine Club for such fees and costs. Further I agree and understand that any disputes arising out of this Agreement will be decided pursuant to the laws of the State of Illinois and venue shall be in Illinois.
	VALID DATES  These agreements, waivers, and authorizations will remain valid and in force as long as and whenever my Dog participates in any activity at or with Chicago Canine Club.
	<b>WARNING</b> By signing this document, I acknowledge that if my Dog is or I am hurt or property is damaged during my Dog's participation activities at Chicago Canine Club, I may be found, by a court of law, to have waived my right to maintain a lawsuit against Chicago Canine Club on the basis of any claim from which I have released them herein.
